

FDA GUIDANCE REGARDING MICROBIAL TESTING FOR SPROUTS

Failure to adopt effective preventive controls can be considered insanitary conditions which may render food injurious to health. Food produced under such conditions is adulterated under the act (21 U.S.C. 342(a)(4)). FDA will consider enforcement actions against any party who does not have effective preventive controls in place, in particular, *effective microbial testing*.

Seed should be sanitized as per label on bag or FDA Guidance referenced above. Even if only a few pathogens survive a seed disinfection treatment, they can grow to high levels during sprouting and contaminate the entire batch. Therefore, seed disinfection treatments should be combined with microbial testing to ensure that pathogens are not present before sprouts enter the food supply.

FDA recommends that a spore test for pathogens including *ecoli*, *D157*, *salmonella*, *listeria monocytogenes*, etc by collecting a sample of spent irrigation water from each production lot or batch prior to release. More information available at <http://www.fda.gov>.
